# XIII Special terms and conditions applying to brokerage transactions on the BÉT and the BETa market through the NetBankár system:

- Only limit price offers can be submitted through the NetBankár system, with the following validity periods: daily offer, valid until the end of the given trading day, offer valid until a specific date but not beyond 360 calendar days, offer valid until withdrawal, but not beyond 360 calendar days.
- Orders may be submitted 7/24 via the NetBankár system but they will only be executed during trading hours.
- Withdrawal of orders submitted through the NetBankár channel may be requested through the TeleBankár service or in the branch office network.
- The list of the securities available at any given time through the NetBankár channel is accessible in the NetBankár channel under the Betétek, értékpapírok, Befektetési lehetőségek (Deposits, Securities, Investment opportunities) menu.



- All orders received through the NetBankár system will be checked by the Bank for conformity to the Business Code before transferring them to the trading systems of the BÉT and/or the BETa market.
- The Bank shall have the right to suspend the NetBankár service to the necessary extent, or even fully, during regular maintenance or recovery after a failure, about which it shall send notification in the form of a system message. The Bank enables its customers at times of service outages to submit orders by telephone, fax or in person during exchange trading hours.

## 1. MBH Bank Plc. engages the following sub-depositaries in the performance of its standard deposit management activity:

- 2. Bank of New York Mellon SA/NV, Brussels
- 3. Clearstream Banking Luxembourg

## 2. The securities that can be accepted for deposit management and/or distributed under commission agency or sale and purchase contracts by MBH Bank Plc.

- 1. Securities issued by the Hungarian State
- 2. securities issued by MBH Bank Plc.
- 3. Any security in relation to which MBH Bank Plc.. acts as distributor in the course of its public or private offering under a contract concluded with the issuer
- 4. In addition to the above any securities traded on the Budapest Stock Exchange (BÉT)
- 5. Of the securities issued in the United States of America, Germany, Great Britain or France in US dollars (USD), euros (EUR) or in pounds sterling (GBP) those that are traded in the trading systems of the XETRA-Deutsche Börse<sup>35</sup> the New York Stock Exchange (NYSE), the London Stock Exchange or Euronext, Paris.

Of the securities referred to in Sections 4 and 5 MBH Bank Plc. only accepts those, or accepts orders only for the trading of those, on which public data and information are available in the professional data service provider systems (e.g. BLOOMBERG, REUTERS) and which are liquid in the above mentioned trading systems.

In accordance with its Code of Practice on the Performance of investment service providing activities and the provision of ancillary services MBH Bank Plc. is under no obligation to accept the Customer's proposal for contracting.

#### 3. Calculation of the uniform yield indicator

Pursuant to Government Decree 82/2010. (III.25.) on the calculation of deposit rates and securities' yields (Decree) the uniform yield indicator is calculated for debt securities and – in the case specified in the Decree – investment units on the basis of the following formula:

#### 5. Deposit management fees:

In the case of deposit management contracts (if no separate fee applies under the contract) the fees applied in the case of the consolidated securities account are charged.

#### 6. The fees included in the list of conditions

The fees specified in the list of conditions – unless otherwise stipulated in the list of conditions – are the final and full prices of the services, regardless of whether in its performance MBH Bank Plc. engages or does not engage any third party provider.

MBH charges the fees in Hungarian forints to the Customer's customer account kept with the Bank. The Bank converts fees, commissions and costs denominated or charged in foreign currencies into forints at the official MNB exchange rate in place on the last working day of the given fee period in the case of portfolio fees, or on the day of charging, in the case of other cases.

If the Customer uses an MBH service package, the MBH Kivételes Current Account service, credit, loan or other service, the Bank provides the simultaneously used bank account management service, deposit management service, bank card services, telephone services or electronic services under the terms and conditions specified for such services in the relevant and effective lists of conditions, charging the fees and costs specified in the same. In case any such lists of conditions contains any reference in the case of any service to the Bank's standard retail/corporate terms and conditions, the Bank applies the terms and conditions and charges the fees and costs specified in the list of condition applying to the given service.

For any individual or one-off service deviating from the stipulations of the list of conditions the Bank will make an individual price quote.

#### 7. Due dates of the fees:

- the portfolio fee and the fee for the posting of immediate notification are due and payable monthly (fee calculation period) or upon the termination or lapse of the account/contract.
- · in the case of a custody contract the custody fee is due and payable on the last banking day of the calendar year or upon the termination or lapse of the contract,
- other fees and commissions are due and payable upon the execution of the transaction concerned.

The rate of the interest for late payment charged upon late payment of fees, commissions and costs payable to MBH, or any other debt accrued towards the Bank – items not regulated by the relevant contracts – equals, unless otherwise stipulated in a relevant contract, the default interest rate stipulated in the prevailing Civil Code.

## 8. Offsetting of money claims

As coverage for the Customer's payment orders and in exercising its right to offset the Customer's debt to the Bank as stipulated in Section 6:49 of the Civil Code and subsection 5.2.3 of the Bank's Code of Practice on Bank account keeping, deposit management and the related services, the Bank has the right to take into account and use the disposable balances on the customer accounts relating to the Customer's consolidated securities accounts as well.

The Bank reserves the right to establish individual commission and fee items and interest rates, to modify the list of conditions and to inform its customers of changes in its conditions in the way specified in its business code (in its premises open to customers).
