

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

**Type** The product is in the form of a certificate issued under English law. It is not an interest bearing security. The payment obligations of the product manufacturer are not guaranteed by any entity.

**Term** The product has a fixed term and will be due on July 19, 2027, subject to an early redemption.

**Objectives** The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Geberit AG (ISIN: CH0030170408), LEG Immobilien AG (ISIN: DE000LEG1110) and Wienerberger AG (ISIN: AT0000831706), listed on SIX Swiss Exchange AG, XETRA and Wiener Börse AG, respectively (the **underlying assets**). The term of the product will end no later than July 19, 2027. However, the product may terminate early depending on the performance of the underlying assets. Each certificate has a face value of EUR 1,000. The issue price is 100.00% of the face value. The product is not listed on an exchange. The subscription period is from June 21, 2023 to July 12, 2023. The issue date is July 19, 2023.

**Autocall feature:** If the closing price of each underlying asset on any autocall observation date is at or above its autocall barrier, the product will terminate on the corresponding autocall payment date. In this case, you will receive an autocall payment for each certificate that you hold. Autocall observation dates are each trading day rolling annually from July 12, 2024 (inclusive) to July 12, 2026 (inclusive). Autocall payment dates are dates falling 5 business days after each autocall observation date. Autocall payment for the first autocall payment date is EUR 1,076.00 and will subsequently increase by EUR 76.00 with each autocall payment date.

### Repayment at maturity:

This section applies only if no autocall occurs as described above.

On July 19, 2027, for each certificate that you hold:

1. If the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on July 12, 2027 is at least equal to its initial reference price, you will receive EUR 1,304.00; or
2. *Otherwise*, you will receive EUR 1,000.00;

The initial reference prices and autocall barriers are shown below.

The initial reference price of an underlying asset is the closing price of such underlying asset on July 12, 2023.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying assets, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

**Intended retail investor** The product is intended to be offered to retail investors who:

1. have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
2. seek capital growth, expect the movement in the underlying assets to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;
3. accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise are not able to bear any loss of their investment;
4. are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below; and

5. are making use of professional advice.

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product until July 19, 2027. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before July 19, 2027. If we are not able to pay you what is owed, you could lose your entire investment.

Inflation erodes the purchasing value of cash over time and this may result in the decline in real terms of any capital reimbursed.

**Performance scenarios** What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The favourable, moderate and unfavourable scenarios represent possible outcomes that have been calculated based on simulations using the reference assets' performance over up to 5 past years. In the case of an early redemption, it has been assumed that no reinvestment has occurred. The stress scenario shows what you might get back in extreme market circumstances. This product cannot be easily cashed in. If you exit the investment earlier than the recommended holding period you do not have a guarantee and you may have to pay extra costs.

The amounts shown here consider two different scenarios (early call and maturity). In case you decide to exit before the product ends, exit costs may apply in addition to the amounts shown here.

### How long should I hold it and can I take money out early?

#### **Recommended holding period: 4 years**

The recommended holding period for the product is 4 years as the product is designed to be held until maturity; however the product may terminate early due to an autocal or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
