## You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?
 guaranteed. The payment obligations of the product manufacturer are not guaranteed by any entity.

Term The product has a fixed term and will be due on November 18, 2025.
Objectives The product pays interest that is linked to the performance of the underlying assets (as defined below). What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Chevron Corporation (ISIN: US1667641005) and Engie (ISIN: FR0010208488), listed on New York Stock Exchange and Euronext Paris S.A., respectively (the underlying assets). The product has a fixed term, ending on November 18, 2025. Each certificate has a face value of USD 1,000 . The issue price is $100.00 \%$ of the face value. The product is not listed on an exchange. The subscription period is from April 22, 2024 to May 10, 2024. The issue date is May 17, 2024.
Interest: If the closing price of each underlying asset on November 10, 2025 is at or above its interest barrier, you will receive interest of USD 137.25 on November 18, 2025 for each certificate that you hold.
Repayment at maturity:
On November 18, 2025, you will receive USD 1,000.00 for each certificate that you hold.

The initial reference price of an underlying asset is the closing price of such underlying asset on May 10, 2024.
The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying assets, the product and the product manufacturer. Intended retail investor The product is intended to be offered to retail investors who:

What are the risks and what could I get in return?


The risk indicator assumes you keep the product until November 18, 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
We have classified this product as 2 out of 7 , which is a low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.
Be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
You are entitled to receive back at least $100.00 \%$ of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. ## Recommended holding period: 1 year and 6 months

The recommended holding period for the product is 1 year and 6 months as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity.
The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-bycase basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
