You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Term

Type The product is in the form of a certificate issued under English law. It is not an interest bearing security. The payment obligations of the product manufacturer are not guaranteed by any entity.

The product has a fixed term and will be due on February 23, 2028, subject to an early redemption.

Objectives The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Commerzbank AG (ISIN: DE000CBK1001), GSK plc (ISIN: GB00BN7SWP63) and SAP SE (ISIN: DE0007164600), listed on XETRA and London Stock Exchange (the **underlying assets**). The term of the product will end no later than February 23, 2028. However, the product may terminate early depending on the performance of the underlying assets. Each certificate has a face value of HUF 100,000. The issue price is 100.00% of the face value. The product is not listed on an exchange. The subscription period is from January 29, 2024 to February 16, 2024. The issue date is February 23, 2024.

Autocall feature: If the closing price of each underlying asset on any autocall observation date is at or above its autocall barrier, the product will terminate on the corresponding autocall payment date. In this case, you will receive the autocall payment shown below for each certificate that you hold.

The initial reference price of an underlying asset is the closing price of such underlying asset on February 16, 2024. 

- The product is intended to be offered to retail investors who:

 - seek capital growth, expect the movement in the underlying assets to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;
 - accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise are not able to bear any loss of their investment;

What are the risks and what could I get in return?







The risk indicator assumes you keep the product until February 23, 2028. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before February 23, 2028. If we are not able to pay you what is owed, you could lose your entire investment. Inflation erodes the purchasing value of cash over time and this may result in the decline in real terms of any capital reimbursed.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years The recommended holding period for the product is 4 years as the product is designed to be held until maturity; however the product may terminate early due to an autocall or an extraordinary event. You have no contractual right to terminate the product prior to maturity. The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-bycase basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
