Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The product is in the form of a certificate issued under English law. It is an interest bearing security, but your interest is not certain and will depend on the performance of the underlying assets (as defined below). The payment obligations of the product manufacturer are not guaranteed by any entity.

Term

The product has a fixed term and will be due on July 13, 2027.

Objectives

The product pays interest that is linked to the performance of the underlying assets (as defined below). What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of The Walt Disney Company (ISIN: US2546871060), Netflix, Inc. (ISIN: US64110L1061) and Spotify Technology S.A. (ISIN: LU1778762911), listed on New York Stock Exchange and NASDAQ Global Select Market (the **underlying assets**). The product has a fixed term, ending on July 13, 2027. Each certificate has a face value of HUF 100,000. The issue price is 100.00% of the face value. The product is not listed on an exchange. The subscription period is from June 11, 2025 to July 3, 2025. The issue date is July 10, 2025.

Interest: If the closing price of each underlying asset on July 6, 2027 is at or above its interest barrier, you will receive interest of HUF 20,000.00 on July 13, 2027 for each certificate that you hold.

Repayment at maturity:

On July 13, 2027, you will receive HUF 100,000.00 for each certificate that you hold.

The initial reference price of an underlying asset is the closing price of such underlying asset on July 3, 2025.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying assets, the product and the product manufacturer. What are the risks and what could I get in return?





Higher risk



The risk indicator assumes you keep the product until July 13, 2027. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before July 13, 2027. If we are not able to pay you what is owed, you could lose your entire

How long should I hold it and can I take money out early?

Recommended holding period: 2 years

The recommended holding period for the product is 2 years as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis.
