This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

Term Objectives The product is in the form of a certificate issued under English law. It is an interest bearing security. The payment obligations of the product manufacturer are not guaranteed by any entity.

The product has a fixed term and will be due on October 10, 2029, subject to an early redemption.

The product provides the potential for capital growth and pays a fixed rate of interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Micron Technology, Inc. (ISIN: US5951121038), Oracle Corporation (ISIN: US68389X1054) and SAP SE (ISIN: DE0007164600), listed on NASDAQ Global Select Market, New York Stock Exchange and XETRA, respectively (the **underlying assets**). In addition, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than October 10, 2029. However, the product may terminate early depending on the performance of the underlying assets. Each certificate has a face value of EUR 1,000. The issue price is 100.00% of the face value. The product is not listed on an exchange. The subscription period is from September 8, 2025 to October 3, 2025. The issue date is October 10, 2025.

Interest: On April 13, 2026, you will receive interest of EUR 517.50 for each certificate that you hold.

Autocall feature: If the closing price of each underlying asset on any autocall observation date is at or above its autocall barrier, the product will terminate on the corresponding autocall payment date. In this case, you will receive an autocall payment for each certificate that you hold. Autocall observation dates are each trading day rolling annually from October 5, 2026 (inclusive) to October 3, 2028 (inclusive).. Autocall payment dates are dates falling 5 business days after each autocall observation date. Autocall payment for the first autocall payment date is EUR 535.00 and will subsequently increase by EUR 35.00 with each autocall payment date. **Repayment at maturity:**

This section applies only if no autocall occurs as described above.

On October 10, 2029, for each certificate that you hold:

- If the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on October 3, 2029 is at least equal to its initial reference price, you will receive EUR 640.00; or
- 2. If the closing price of any underlying asset rises to or above its star price on October 3, 2029 you will receive EUR 500.00; or
- If the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on October 3, 2029 is at least equal to its barrier price, you will receive EUR 500.00; or
- 4. <u>Otherwise</u>, you will receive EUR 500.00 multiplied by (i) the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on October 3, 2029 divided by (ii) the strike price of such underlying asset.

The initial reference price of an underlying asset is the closing price of such underlying asset on October 3, 2025.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying assets, the product and the product manufacturer. The risk indicator assumes you keep the product until October 10, 2029. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

The recommended holding period for the product is 4 years as the product is designed to be held until maturity; however the product may terminate early due to an autocall or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-bycase basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
