You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type

Objectives

The product is designed to provide a return in the form of a cash payment on the maturity date in an amount that depends on whether the worst performing underlying satisfies the barrier conditions specified below. The product has a fixed term and will terminate on the maturity date, unless terminated early.

Early termination following an autocall: The product will terminate prior to the maturity date if, on any autocall observation date the reference price of the worst performing underlying is at or above the relevant autocall barrier price. On any such early termination, you will on the immediately following autocall payment date receive a cash payment equal to the applicable autocall payment. Termination on the maturity date: If the product has not terminated early, on the maturity date you will receive:

- if the final reference price of the worst performing underlying is at or above 75.00% of its initial reference price a cash payment equal to EUR 1,300.00;
- otherwise, if the final reference price of the worst performing underlying is above 60.00% of its initial reference price and below 75.00% of its initial reference price a cash payment equal to EUR 1,000.00;
- otherwise, if the final reference price of the worst performing underlying is at or below 60.00% of its initial reference price (i) the product notional amount multiplied by (ii) (A) the final reference price of the worst performing underlying divided by (B) its initial reference price.

Under the product terms, certain dates specified above and below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlyings, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. Disregarding the impact on your return in that scenario, the estimated entry and exit costs as a percentage of the **product notional amount** are estimated to be 8.97% if you cash in after year 1 and 7.97% if you cash in after the recommended holding period.

5. How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 29 April 2022 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is listed) or (2) off-exchange, where an offer for such product exists. No fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable.
